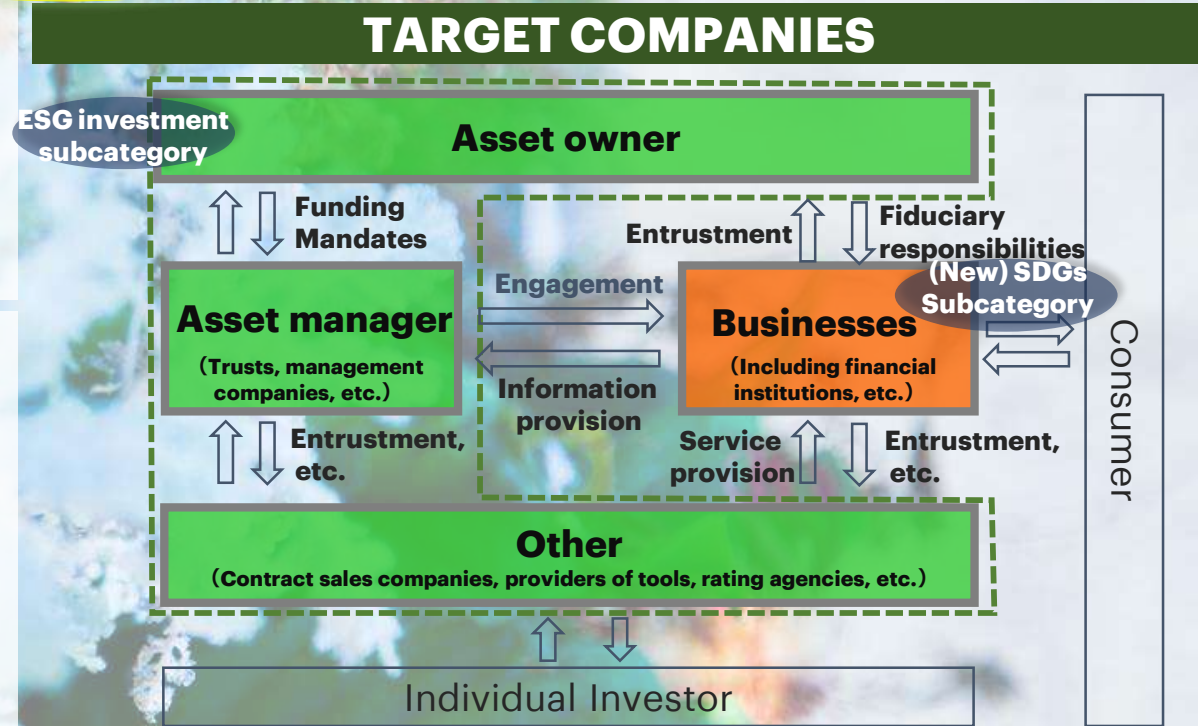

Tokyo Financial Award provide opportunities for Businesses to spread **ESG investment strategy** and **SDGs management practices** in Tokyo, Japan, and the world.

Since FY2018, “Tokyo Financial Award” has been held by the Tokyo Metropolitan Government as part of the “Global Financial City: Tokyo” Vision, to recognize financial companies that develop and provide innovative financial products and services that address the needs of Tokyo residents & companies, as well as those who are contributing to the spread of ESG investment. In the ESG investment category of Tokyo Financial Award 2020, we are calling for measures taken by financial institutions to promote **ESG investment (ESG investment subcategory)**, and this year we are also calling for **SDGs management (SDGs subcategory)** that is practiced by businesses (including financial institutions). About **three companies in both categories will be awarded** for their innovative and unique efforts.

- ESG investment subcategory : Evaluating unique ESG investments and measures by asset owners, asset managers, rating agencies, etc.
- SDGs subcategory : Evaluating unique SDGs efforts of businesses.
- ※It is possible to apply for both subcategories (e.g., financial institutions can apply for both the ESG investment subcategory and SDGs subcategory).



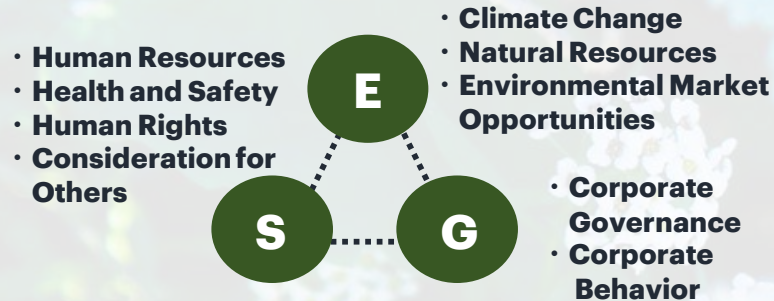

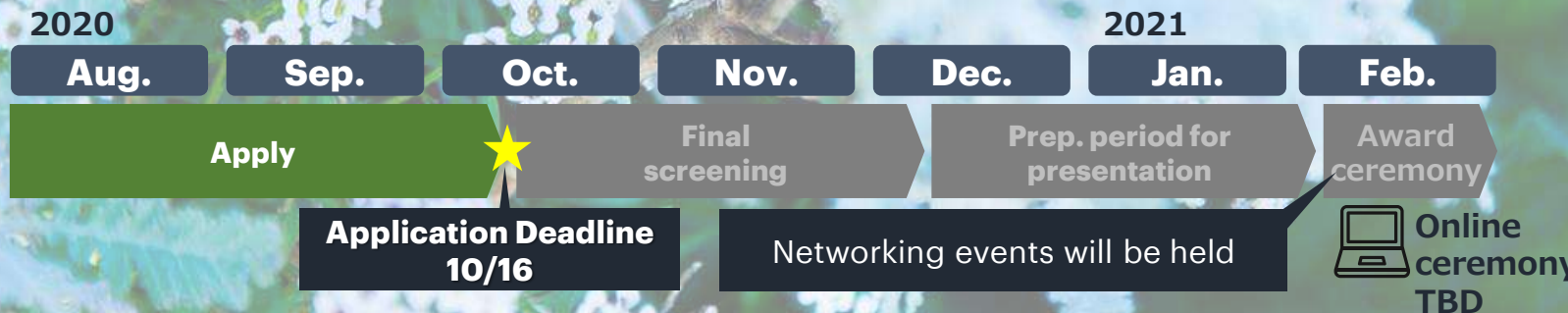
